On May 21, 2009, the Washington State Conservation Commission took action on applications for the position of appointed supervisor on conservation district boards.

We will be sending official notification letters to all applicants for appointment in the next two weeks. The term of office for these positions started yesterday, May 21, 2009, and will expire on the third Thursday in May three years later, on May 17, 2012.

New conservation district supervisors may begin their service at the next regular or special meeting of your board of supervisors. Incumbents who did not reapply for appointment and were not challenged for their seat continue to serve another full term.
